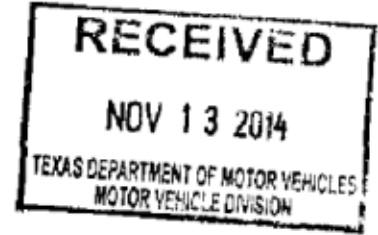
# LEMON LAW COMPLAINT FORM
